

## Application for Season Public Swim Pass

The Colony Aquatic Park sells two types of discounted season Public Swim Passes:

- **INDIVIDUAL**- no documentation other than annual proof of residency is required. Please create or update your PlayTC.com account and stop by TCAP to purchase a pass.
- **FAMILY**- must meet the definition of family (below) AND annually show proof of kinship.

Because the entry price is deeply discounted, our FAMILY rate is only available to direct family members and “add-ons” will not be tolerated. Proof of family connections must be provided prior to the purchase, and is required annually, because we do not keep your documentation.

Please prepare this form in advance of coming to purchase your pass. Retroactive discounts will not be applied for entries on swim days prior to formal pass purchase.

We are delighted to offer you a safe, affordable, clean environment and make every attempt to meet all of your swim needs! Please remember, if you do not wish to provide formal documentation for the Family Pass, our Individual Pass also offers a healthy discount for the season!

### Family Pass Steps to Purchase

1. Create or update your account at PlayTC.com
2. Locate document(s) to show proof of kinship. (Often, only one is necessary)
3. Bring this form and kinship document(s) by the Aquatic Park to finalize your purchase. If you want to check our available staffing hours, please call (972)624-2225. THANKS!

**Proofs of family unit/dependency** include only the following **without exceptions of any kind:**

- most recent tax return documentation (i.e. yr 2018),
- birth certificates for minors with same last names as parents (18 & under),
- health insurance where dependent and parent are listed as covered and the same card,
- court approved adoption papers (with signature or seal),
- paperwork for court approved foster children living at residence,
- marriage certificate for blended families

**Definition of a “Family”** for purposes of buying a discounted seasonal pass

- An adult couple living in one household with dependent children, or a single parent with dependent children.
- Only two family members can be over the age of 18.
- Children can be added IF they have not turned age 18 before August 15, this year.
- If married and filing taxes individually, then the address on tax information must match and dependents must be listed on either form.

- If family members have different last names, then proof of a birth certificate for dependents is required.

Siblings (or other relatives) 18 years of age and older who live together do not qualify for the discount and should consider purchasing Individual Passes or Separate Family Passes (for example, two brothers living together with their children).

Grandparents, cousins, aunts, uncles, in-laws, nannies, groundskeepers, housekeepers, roommates, etc., do not qualify. Again, we reserve the right to not issue and/or charge the discounted amount before any of the passes are issued.

To save yourself time, please have this form prepared before coming to Aquatic Office for Pass Purchase.
