- **Contact the Court for offenses not listed**
- **Cannot take Drivers Safety Course for violations that occur in a Construction Zone**
- **Cannot take Drivers Safety Course or Deferred Probation if you had a Commercial Driver's License at the time of the offense**
- **Juveniles MUST appear in Open Court to speak with the Municipal Judge**
- **After Hours Drop Box is located at the front of the building / Envelopes are available for your use / Please make sure you put your Name/Citation Number on the money order for identification purposes**
- **Acceptable forms of payment: Cash, Money Orders, MasterCard/VISA. We DO NOT accept personal checks**
- **ASSAULT-FV or ASSAULT offenses are REQUIRED to come to Open Court in order to enter a plea in front of the Judge. You cannot pay these violations online.**

OPTION #1 (PLEASE INITIAL)

DEFERRED PROBATION / 120 DAYS OR 180 DAYS

If you want to keep violations off your driving/criminal record you may request do to Deferred Probation. You will need to enter a plea of either NO CONTEST or GUILTY and pay the necessary fine/costs associated with the violation. The terms of your probation will be based on the nature of the violation. Your probationary period will be 120 days. (Fail to Maintain Financial Responsibility – 180 days). Please contact the Municipal Court for all fine/costs.

OPTION #2 (PLEASE INITIAL)

DRIVING SAFETY COURSE

If you want to do a Driving Safety Course, you will need to provide a copy of your Driver’s License and Valid Insurance Card, with you name printed on the card along with the necessary costs. (**\$149 Regular Zone/Moving Violation; \$174 School Zone**) 1) you have to have a valid Texas Driver’s License, 2) you were cited with a moving violation (defendants cited for going 25 miles over the speed limit are not eligible for this option), 3) you have not taken a course for the purpose of dismissing a citation within the past twelve (12) months nor are you currently taking a course to dismiss a citation, and 4) you must provide PERSONAL PROOF OF INSURANCE.

When you make your appearance at the court or via mail, you will need to pay the administrative fee/costs and provide a copy of your State issued identification/driver’s license.

If you decide to make your request by mail, please contact the court for accurate fine/cost amounts. You are responsible for any amount that is not paid in full. Please make sure you add your Name/Citation number to your money order to make sure the amount is credited to the correction violation.

FAILURE TO RESPOND BY THE INITIAL APPEARANCE DATE SHOWN ON THE CITATION MAY RESULT IN ADDITIONAL CHARGES/FEEES; IN ADDITION TO A WARRANT FOR YOUR ARREST BEING ISSUED.
